As part of Amnesty International USA (AIUSA), Group 11 has been in the forefront of protecting human rights for over 40 years. We help free prisoners of conscience, participate in country campaigns, and undertake special projects.

Over the years, Group 11 members have worked on numerous human rights cases and special projects. Past projects have included holding a major conference on women and human rights, supporting an international bill of rights for women, and teaching a course on human rights in New York City's public schools. Since 1975 we have sponsored an annual concert to raise funds for AIUSA and our group. In 2014, Group 11 published a book of correspondence between a member and a Ukrainian prisoner of conscience.

Current and Recent Cases

Zeynab Jalalian, Iran

Zeynab Jalalian was sentenced to death in early 2009 after being convicted of "Moharebeh" ("enmity against God"). Her conviction was based on her alleged membership in a Kurdish armed opposition group. Her death sentence was commuted after a campaign launched by Amnesty International. We are now seeking to obtain a new trial, end her ill treatment in prison, and make sure she receives adequate medical care.

Teodora del Carmen Vásquez, El Salvador

Teodora del Carmen Vásquez was convicted in 2008 of "aggravated homicide" and sentenced to thirty years in prison after suffering a stillbirth at work. Despite what actually happened to her, she was presumed guilty of having an abortion. Being from a poor rural family, Teodora could not afford an effective legal team to defend her rights. Her current lawyers describe her previous trial as lacking in due process and suffering from inconsistencies. Group 11 seeks to release Teodora from prison immediately.

Nguyễn Văn Lý, Vietnam

Father Nguyễn Văn Lý, a Vietnamese Catholic priest, was released from prison on May 20, 2016. He had been a prisoner of conscience for advocating free speech and was subject to hard labor, solitary confinement, and house arrest for over 15 years. Group 11 has worked to ensure Father Ly's release by sending letters and petitions to Vietnamese authorities. Group 11 is gratified that Father Ly has finally been released from his long term of unjust imprisonment.
